## Champion Classrooms Courses and Webinars

### 7 Generations: A Look Back at American Indian Families

Historical trauma has impacted generational cycles of parenting and coping of families in tribal communities. This webinar explores the influences of historical trauma and intergenerational grief and loss on American Indian families, the impact the loss of children to boarding schools, and child welfare has had on American Indian family systems.

### Missing Threads, The Story of the Wisconsin Indian Child Welfare Act

This webinar features a virtual screening of the award-winning film Missing Threads: The Story of the Wisconsin Indian Child Welfare Act. First-hand accounts are shared by family members who were negatively impacted when Indian children were placed into foster care and disconnected from their families and culture. A Q&A session with Susan Reetz, the writer, producer, and director of this powerful documentary, follows the screening.

### The Impact of Historical Trauma on Indigenous Peoples: Building Resiliency Through Culture

This presentation provides an overview of the multifaceted dynamics of power and control that exist within intimate partner violence, the impact on children in the home, and how similar factors have historically impacted Indigenous Peoples. We will discuss how culture and tradition have alternatively guided balance and equality to promote healthy relationships and build resiliency. ### The Impact of ICWA Courts: Approaches to Improving Outcomes for Indian Families

ICWA Courts are specialty courts that have improved legal compliance and implementation of the spirit of the law in their respective jurisdictions through focused state-tribal partnerships. ICWA stands as the “gold standard in child welfare,” with active efforts to prevent removal and ensure reunification at the center of this important law. There are now 25 ICWA Courts nationwide using meaningful Tribal collaboration and cultural humility with Indian families to improve outcomes and sustain connections. In this presentation, attendees will learn about ICWA Courts, data outcomes, and how Tribal advocacy has impacted permanency outcomes for Tribal families in ICWA Court jurisdictions. Attendees will also understand how a state-tribal partnership team approach can improve relationships among all those working to improve outcomes for Tribal families. ### 7 Generations: How to Care for Indigenous Children and Their Culture

This webinar takes a closer look at American Indian families and focuses on how Indigenous culture helps build resiliency in its children. You will gain an understanding of some universal values of American Indian cultures, especially among the 11 federally recognized tribes in Wisconsin. Participants can also expect to leave with actionable tips to develop more effective, culturally competent approaches for working with American Indian children and families. Presented by: Alebra Metoxen, MSW, who is an enrolled member of the Oneida Nation and is also from the Cheyenne River Sioux Tribe.

### Fatherhood Is Sacred®, Motherhood Is Sacred®

This webinar outlines the approach to a highly successful parenting curriculum developed by a Native American father for Native American fathers and mothers. It is the model overview of training fathers and mothers to be leaders in their own homes. The workshop identifies the five core principles of the curriculum offered to facilitators who work with Native American parents on and off reservations: the Creator, Choice, Teachable, Wisdom, and Service. Parents learn the importance of loving and caring for their families, assisting with problem-solving, and teaching the true principles of fatherhood and motherhood. Presented by: Albert M. ### Boys with Braids

The Boys With Braids webinar raises awareness about the cultural and spiritual significance of braids for Native boys and men. It highlights the importance of identity, resilience, and cultural pride while addressing stereotypes and promoting understanding among families, schools, and communities. Through storytelling and education, the presentation fosters respect for traditional practices and encourages positive self-identity for Native youth.
